These roadways were not created with bikes and pedestrians in mind. Your inaction in developing safe roadways is irresponsible, at least. In most states you should file a claim within 6 months and a lawsuit within 1-2 years of the accident date. Strong proof consists of paperwork of flaws, evidence the city had notification, professional evaluations, witnesses, and thorough paperwork of your damages. You must confirm the city found out about the harmful road issue yet failed to properly maintain, repair, or warn drivers about it.
