

When a family loses someone in a preventable wreck, the legal question is not the first thing on anyone's mind. It becomes one later, usually when the bills arrive or an insurer calls.

Georgia handles a death case differently than most people expect. Two separate claims generally exist. One belongs to the surviving family and covers what the law calls the full value of the life that was lost. The other belongs to the estate and covers the last medical expenses, the funeral, and any conscious pain before death.

Who may bring the first claim follows an order set by statute. It generally begins with a surviving spouse, then children, then parents, and then the estate. Where there is a spouse and children, Georgia [experienced Atlanta personal injury attorney](#) also sets a minimum share for the spouse.

Deadlines apply, and some are shorter than people expect. A claim involving a city, a county or a state agency can require written notice long before a lawsuit is due. Evidence also thins out, particularly where a commercial vehicle or a business is involved.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
