

A rideshare wreck raises a question a normal car crash does not: which insurance policy actually applies. The answer turns on what the app was doing when the crash happened.

If the app is off, it is an ordinary car wreck, and their personal policy applies. Once the app is on and the driver is waiting for a request, a limited amount of coverage usually applies. Once they have accepted a ride or have a passenger in the **atlanta personal injury attorney** car, a far larger commercial policy usually applies.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
