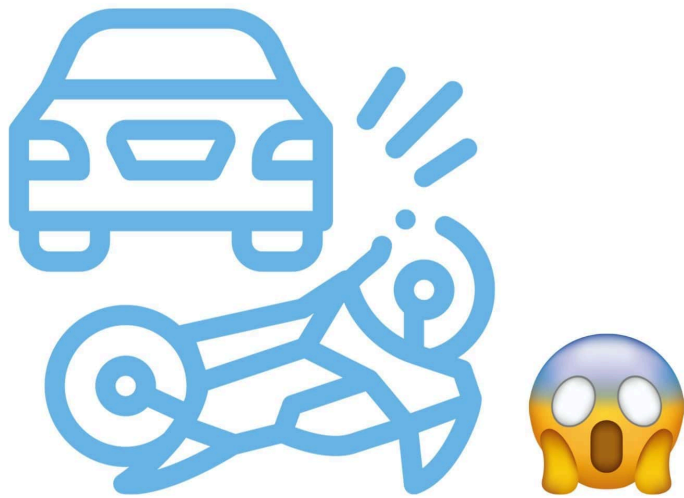

## HOW MUCH IS MY CAR ACCIDENT CASE WORTH IN DALLAS?

The statute of limitations for an automobile accident begins on the day of the collision. In West Virginia, this means you have two years from when the collision occurred to submit a mishap claim. If a car crash took place on March 2, 2021, the sufferer would have until March 2, 2023, to lawfully file a claim. Along with your injury claim declaring due date, you ought to recognize various other needs after a Texas auto accident. Hence, in many cars and truck crash injury insurance claims, your due date is 2 years from the crash day to submit your insurance claim. However, if you are calling a governmental entity as a defendant, your deadline for filing notification is six months from the car crash day.
