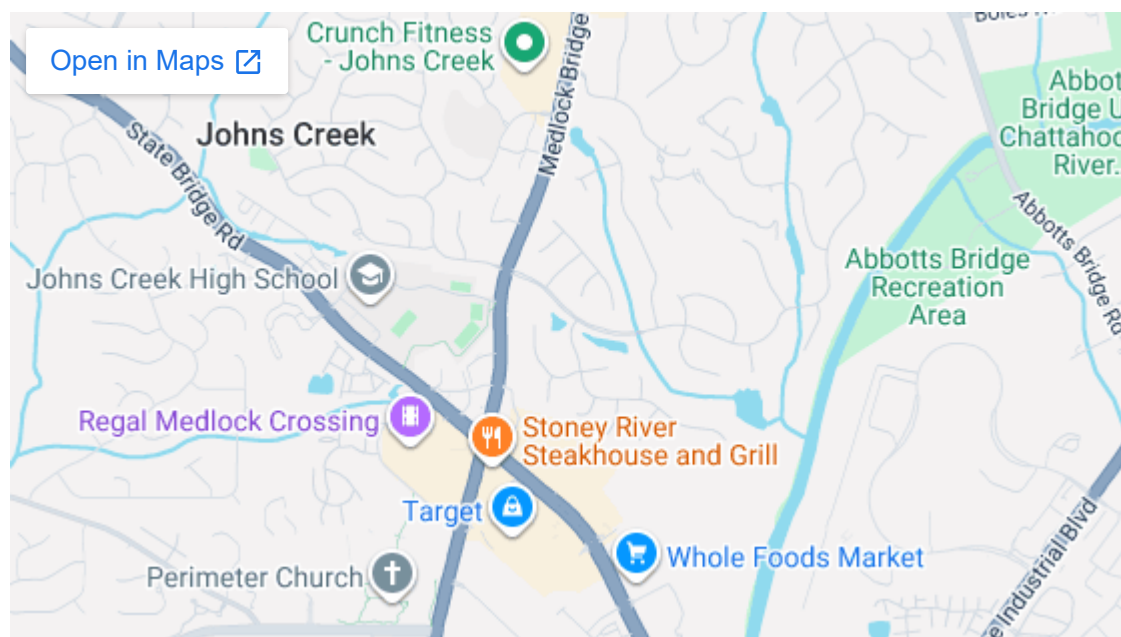
Services That Help
